

## Covid-19 Amendment Regulation (CAR) Subject Declaration Form

# Business

This Subject Declaration Form allows you to match your degree (and other qualifications if applicable) against the Teaching Council's curricular subject requirements. You must meet the requirements for at least one curricular subject in order to be eligible for registration as a Post-primary teacher, having also completed a programme of Post primary initial teacher education that meets the Council's requirements.

This declaration form should be completed, printed and signed by persons applying for registration as a Post-primary teacher under CAR and forwarded with the CAR-01 (COVID-19 Amendment Regulation) Application Form.

You should complete a subject declaration form for each subject for which you are seeking Teaching Council registration.

The requirements for the curricular subject **Business** are set out on page 2.

**Any material errors or misleading declarations made on this form may result in refusal of registration.**

Based on this declaration form, your transcripts relating to the curricular subject sought and the transcripts of your initial teacher education qualification, the Teaching Council will confirm if, you will be eligible to register as a Post-primary teacher and which curricular subject(s) will be recorded on the Register of Teachers.

The information you provide on this form is a guide only and will be used to inform the Council's assessment process. The final decision on the suitability of content and credits allocated will be made by the Teaching Council. You will be registered for the curricular subject(s) for which you meet the requirements in full. If you do not meet the requirements in full for any subject you may be registered for the subject for which you are closest to meeting requirements (subject to conditions) as determined by the Council.

In order to meet the registration requirements set down in the Teaching Council [Registration] Regulations in respect of the curricular subject of Business, an applicant must meet **all** of the following criteria:

- (a) Applicants must hold a degree-level qualification, with Business studied up to and including third-year level or higher (or modular equivalent).
- (b) The qualifying degree must be equivalent to at least Level 8 on the National Framework of Qualifications (NFQ) and with a minimum pass<sup>1</sup> result in all examinations pertinent to the subject of Business.
- (c) The qualifying degree must carry at least 180 ECTS (European Credit Transfer System) credits (or equivalent) with the specific study of Business comprising at least 60 ECTS credits (or equivalent) and with not less than 10 ECTS credits (or equivalent) studied at third-year level or higher (or modular equivalent). *Please note that studies in the areas of Accounting and Economics will not be counted towards the ECTS credit requirement for the Leaving Certificate subject of Business.*

The study of Business during the qualification must show that the holder has acquired sufficient knowledge, skills and understanding to teach the Business syllabus<sup>2</sup> to the highest level in post-primary education (see [www.curriculumonline.ie](http://www.curriculumonline.ie)). To meet this requirement the degree must include the study of at least four of the following Business disciplines:

- (a) Organisational Behaviour
- (b) Business Enterprise and Entrepreneurship
- (c) Management
- (d) Business Environment (Domestic and/or International)
- (e) Human Resource Management
- (f) Marketing
- (g) Business Law

The degree must also have been supported by relevant studies in the application of Information and Communications Technology (ICT) in Business, e.g., Information Systems/E-commerce. (A maximum of 5 ECTS credits (or equivalent) will be allowed towards the overall requirement of 60 ECTS credits.)

Applicants must also have completed a programme of post-primary initial teacher education (age range 12- 18 years).

### Business Studies (Junior Cycle)

An applicant who meets the registration criteria for Business will also be deemed to have acquired the competency to teach the Junior Cycle curricular subject Business Studies if he/she has studied a minimum of 10 ECTS credits (or equivalent) in Accounting and a minimum of 10 ECTS credits (or equivalent) in Economics.

- 3 Applicants who have commenced a programme of initial teacher education prior to 01/09/2014 carrying less than 120 ECTS credits may be exempted from this requirement at the Council's discretion.
